2.0 Access and acceptance

The user, who comes to the facility to buy the laboratory services, is required:

- To obtain a progressive-numbered coupon, from the appropriate distributor installed in the waiting room, in order to regulate the flow of users and individual access to the acceptance and withdrawal procedures. if the coupon dispenser is not active, present yourself at the check-in in order of access to the Laboratory; acceptance will assign a progressive access number to each user.

The user must wait for his turn by staying at a suitable distance, indicated by a special line on the floor, from the reception desk, in order to ensure the privacy of other Users.

Users with special needs such as pregnant women, invalids, the elderly or people with health problems are entitled to priority for the acceptance and execution of the sample. The user must contact the reception staff to report their situation and then wait for their turn, staying at a suitable distance, indicated by a special line on the floor, from the reception desk, in order to ensure the privacy of other Users.

The list of laboratory tests, which the facility is able to carry out, is shown in a special document "INFORMATION TO THE PUBLIC", available at the Reception.

Methods of direct access for users without SSR binding

In order buy analysis services privately, with the cost of the services entirely borne by the user, it is sufficient for the user to indicate to the reception staff the type of examinations they intend to carry out, without "necessarily" showing a medical prescription.

3.0 Privacy and particular personal data protection

In order to protect the user's privacy, in accordance with Legislative Decree 196/2003 and EU / 2016/679 Regulation, the call of patients to the reception desk and in the sampling room takes place through the use of the code eliminator or attributed by acceptance on the basis of the order of access to the Laboratory.

4.0 Precautions for the prevention of infections.

The laboratory staff apply adequate procedures for the prevention of infections, and ensure that as a result of the activities carried out in the facility, the transfer of pathogens to users and from one user to another is avoided.
